The Department has investigated the degradation of your water supply in response to your February 9, 2009, complaint that recent gas well drilling activities conducted by Dominion Transmission, Inc. had affected your spring.

On February 10 and March 16, 2009, the Department collected water samples from the well at your property. The analytical reports for these samples are included, as well as documents that will assist you with interpreting the sample results. The sample results indicate, and therefore the Department has determined, that your water supply has been affected by drilling activities conducted by Dominion Transmission, Inc.

The Department is in the process of working with Dominion Transmission, Inc. in an effort to resolve this matter.
